Eligibility Requirements:

1. Applicants must be admitted and enrolled full time or part time in an accredited law school.
2. Applicants must demonstrate a connection to Durham Region.
3. Applicant must demonstrate past and present acts of volunteerism and community involvement.

To be considered for this scholarship, applicants must submit a completed application and the following additional documents:

- Confirmation of enrollment in a law program
- A cover letter addressing how you meet the eligibility requirements of the scholarship.
- A resume or curriculum vitae.
- Most recent academic transcript.

Completed applications must be received by the Durham Region Law Association by **May 15th, 2023**. Only successful applicants will be notified.
