Law Society of Ontario: Certified Specialist Program

Ministry of Finance: A Permanent Framework for Pension Benefits

On March 15, 2023, the Ministry of Finance launched consultations on proposed regulations necessary for implementing a permanent target benefit framework in Ontario. The consultation closed on June 30, 2023. The government appreciates the comments and feedback it received during this consultation.

FOLA's response to the initial consultation can be found <u>here</u>.

In response to stakeholder feedback, a second paper is now posted for consultation, which includes a set of revised proposals, including:

- A revised approach to the provision for adverse deviations (PfAD) in which plan administrators would have discretion to establish their plan's PfAD in line with the plan's funding and benefits policy;
- Streamlining requirements for the conversion process;



- Permitting the commuted value calculation to include a reduction by the plan's going concern funded status, if required by the terms of the plan; and
- Adding a requirement for plan administrators to establish and file a communications policy, while revising some of the proposed minimum information required to be included in member communications.

This second paper builds on the previous paper by setting out the revised proposals and providing additional details on some of the elements addressed in the previous paper. The second paper can be found at Ontario Regulatory Registry.

Updated Scheduling of Family Matters at the Ontario Court of Justice

We are pleased to report that our *Scheduling of Family Matters at the Ontario Court of Justice* has been updated and is now posted. The modes of appearances have been amended as part of the *Scheduling* notice. You may find the updated *Scheduling* notice here.

There are a few significant changes that we would like to bring to your attention:

1. Rather than in-person, the mode of appearances for initial and continuing case conferences for domestic matters will be virtual hearings. Case conferences and Status Review Applications in *CYFSA* matters will also be virtual rather than in-person.

There will be conditions on the virtual hearings for these appearances – they will depend on technology being available for both the parties, the lawyers and the courts. Also note that the First Appearance Court clerk and/or a judge may direct another mode of appearances for the case conferences.

- 2. Another change concerns the modes of appearances for First Appearance Court. We have introduced a bifurcated approach:
 - In the Northwest and Northeast regions only, parties and their lawyers may attend the First Appearance Court virtually, if technology is available, and unless otherwise directed by a judge; and
 - In the Toronto, Central West and West regions only, parties and their lawyers will be required to attend the First Appearance Court in person, and unless otherwise directed by a judge.

We changed the modes of appearances for First Appearance Courts for a very specific reason: we were no longer receiving any consent agreements out of the First Appearance Courts in southern Ontario.

We have asked and received assurances from Legal Aid Ontario and the mediators that they will appear in-person for these appearances.



First Appearance Courts in the Northwest and Northeast regions may remain virtual. This was done to take into account the long distances and lack of available counsel in the North.

Note that the scheduling notice only includes rules-based events. There are many other appearances that are not covered in the scheduling notice, including garnishment hearings, child interviews, first meetings, secure treatment hearings and reports on child interviews, etc. that are directed by the judiciary.
